PRE-QUALIFICATION CRITERIA

1. a) The Indian Agent/bidder should be a supplier of imported waste paper and should have successfully executed single order for the supply of at least 500 MT of imported waste paper/imported pulp in any category with any end user-customer during the past three years period prior to **June-30th 2024**.

OR

1.b) The Indian Agent/bidder should have imported and executed single order for the supply of value of Rs.1 Crore of raw materials in any category with end user-customer during the past three years period prior to **June 30th 2024** and also should have cumulative supply of Rs. 2 Crore in a year.

2. Please enclose Schedule of Experience as per format at Annexure - V with documentary evidence. In case the Indian Agent/bidder do not have any prior experience , he may be allowed to submit the order copies of their principals for qualifying the pre-qualification criteria along with an authorization from their principals to submit the Bid on their behalf and to deal with KPPL. In this case the documentary proof for the principal meeting their pre-qualification criteria should be submitted.

3. If the bid is submitted by the Indian Agent, they should submit the authorization from the principal to supply the specified quantity.

Bidder should submit Format for Commercial Terms & Conditions duly filled in along with part I of the bid (Annexure V).
