Sample submitted by new vendor/ new product should confirm to KPPL specifications. The bids which are not meeting the qualifying criteria will be rejected and further processing will not be carried out. No correspondence in this regard will be entertained.

Online price bid in prescribed format (BOQ) of technically qualified bidders will only be opened.

KPPL is not bound to accept the lowest quotation and KPPL may accept or reject the lowest quotation or any quotation at its sole discretion and go for re tendering in case the lowest rate obtained in the tender is considered higher or unacceptable.

Bidder should take into account any corrigendum published on the tender document before submitting their bids. Bidders are requested to go through the NIT and the tender document carefully to understand the documents required to be submitted as part of the bid. Bidders, in advance should get ready the bid documents to be submitted as indicated in the tender document in PDF format. Bidders are advised to upload clear scanned documents.

e- Tender link shall remain open from the pre-announced date & time till the specified due date & time. The electronic bid submitted during the e-tender process shall be legally binding on the Bidder. Any bid will be considered

as valid, only if it is submitted in the prescribed format given in the Bid document.
